Gambling expenditure in New Zealand in 2019-20 amounted to \$2.030 billion dollars on the four main forms of gambling.

Expenditure on gaming machines outside of casinos totalled nearly \$NZ 723 million and accounted for 35.6% of all gambling expenditure. Wagering accounted for 14% of gambling expenditure (\$NZ 284 million), while expenditure on lotteries (\$NZ 569 million) accounted for 28% of spending. With expenditure of \$NZ 454 million, casinos accounted for 22.4% of all gambling spending in New Zealand.

In 2019-20 average gambling expenditure in New Zealand per adult was approximately \$NZ 516 - comprising wagering (\$NZ 72 per adult), lotteries (\$NZ 144), gaming machines (\$NZ 184) and casinos (\$NZ 115).









HOUSEHOLD SPENDING COMPARISON

Statistics New Zealand produces a regular *Household Economic Survey* which records the expenditure of a sample of New Zealand households. The latest household expenditure statistics available are for the 2018-19 period. Comparisons between the results gained in 2016 and 2019 are also possible and outlined in Table 4-14. Note that both surveys were based on self-report and gambling expenditure may be under-reported.
